OSU Foundation Office of Corporate and Foundation Relations

Central resource supporting units across Ohio State's campus in the pursuit of corporate and foundation charitable gifts

- Identify, establish and coordinate corporate and foundation support
- Build relationships with corporate and foundation donors
- Work with college/unit development offices to understand needs and priorities
- Work with Office of Research/Sponsored Programs, where possible, on funding opportunities

Sponsored Programs or Development?

Office of Sponsored Programs (OSP)

- Does <u>not</u> have a 501(c)(3) designation
- Sponsored agreements are reciprocal; each party gives and receives something of relatively equal value
- Source of funding
 - •Government (local, state, federal)
 - Foundations
 - •Corporations (Industry Liaison Office)
- Facilities and Administration costs where applicable

The Ohio State University Foundation

- Does have a 501(c)(3) designation
- No expectation of direct benefit or the provision of goods and services to the donor
- Source of funding
 - Individual donors
 - Foundations
 - Corporations
- Six month check hold (administrative costs)
- Leverages strategic partnerships
- Manages relationships

When to approach the Office of CFR:

- Exploring opportunities to supplement government grants with private support
- Limited submission opportunities with private donors (see http://osp.osu.edu/fundo ps/report/ for more detail)

How the Office of CFR can help:

- Relationship building
 - Leveraging corporate or foundation contacts
 - Liaise with other externally-facing units (institutional context)
- Proposals/LOIs
 - Writing and editing
 - Submissions
- Research
 - Foundation prospecting for targeted program needs
 - Open RFPs
